RE: 2018 End of Life Notification

Dear Valued Customer:

ERP is making significant investments to optimize our current production capacity due to dramatically increasing demand for our next generation LED drivers, the “Draco” series of products. During this expansion, we remain committed to existing products with appreciable volume. However, we must eliminate many idle or very low volume models that consume valuable resources through an End of Life [EOL] process. To minimize the frequency of End of Life [EOL] notices to our customers, ERP publishes biannual notifications of discontinued products.

This EOL notice serves as the first from ERP in 2018. The list of products affected is located in Appendix A. Please review Appendix A and the list of products thoroughly to prevent disruptions in your future supply chain. Some products contained in this notice may be part of an ongoing product portfolio renewal at ERP, and as such, have potential replacement products identified. Please note that it is the responsibility of our customers to properly evaluate suggested replacement products for form, fit and functional equivalency given the interdependencies of various customer product designs.

For product model numbers without recommended replacements, ERP requires the placement and receipt of a lifetime-buy purchase order by March 31, 2018 through your normal purchasing channels. **Purchase orders must be received by March 31, 2018 to qualify for delivery before June 30, 2018, the last possible date of shipment of each and every product on the EOL list in Appendix A.** Minimum order quantities may apply through ERP or its licensed distributors. Lifetime buy purchase orders placed with ERP or its licensed distributors carry Non-cancellable, Non-returnable (NCNR) terms. These products will comply with ERP’s standard warranty terms and conditions.
